("Squad") pursuant to which the Squad agrees to furnish ambulance service within the Town of Maine, for the period beginning on January 1, 2025 and ending December 31, 2025. The total payments to be made by the Town to the Squad for the year 2025 under the Agreement shall be \$431,463.00. Those payments include: (a) the approximate sum of \$10,000.00 which the Town shall pay to the Squad from the proceeds of the year 2025 Host Community Agreement Fire Fighting Control and Public Safety contribution to be made by the County of Broome to Town, (b) a sum not to exceed \$228,165.00 which represents the amount to be raised by real estate taxes for ambulance service for the year 2025, and (c) a sum not to exceed \$193,298.00 being the estimated proceeds from Squad billing.

TOWN OF MAINE NOTICE OF PUBLIC HEARING ON FIRE PROTECTION CONTRACTS FOR THE YEAR 2025

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board of the Town of Maine on December 17, 2024 at 6:05 p.m. for the purpose of considering new fire protection contracts between (A) the Town and the Union Center Fire Company, Inc. (Town Fire Protection District No. 2), (B) the Town and the Union Center Fire Company, Inc. (Town Fire Protection District No. 3), (C) the Town and the Glen Aubrey Fire Company, Inc. (Town Fire Protection District No. 4), (D) the Town and the Maine Fire District No. 1 of the Town of Maine (Town Fire Protection District No. 5), (E) the Town and the Maine Fire District No. 1 of the Town of Maine (Town Fire Protection District No. 6), and (F) the Town and the East Maine Fire Company, Inc. (Town Fire Protection District No. 7).

Said new contracts shall be upon the following general terms, to wit:

- 1. Each of said Fire Companies and Fire District shall, at all times during the period of said contracts, be subject to call for attendance upon any fire occurring in such respective fire protection districts, and shall respond and attend upon all fire calls in said respective fire protection districts.
- 2. For such services, payments shall be made by the Town pursuant to said contracts for the year 2025 or as otherwise indicated as follows:
- (A) The sum of \$190,449.00 to Maine Fire District No. 1 of the Town of Maine.
- (B) The sum of \$57,800.00 to Union Center Fire Company, Inc. (Town Fire Protection District No. 2).
- (C) The sum of \$51,700.00 to Union Center Fire Company, Inc. (Town Fire Protection District No. 3).
- (D) The sum of \$10,244.00 to Glen Aubrey Fire Company, Inc. (Town Fire Protection District No. 4)
- (E) The sum of \$12,385.00 to Maine Fire District No. 1 of the Town of Maine (Town Fire Protection District No. 5).
- (F) The sum of \$32,060.00 to Maine Fire District No. 1 of the Town of Maine (Town Fire Protection District No. 6).
- (G) The sum of \$179,684.00 to East Maine Fire Company, Inc. (Town Fire Protection District No. 7). The additional sum of \$10,000 will also be paid by the Town to East Maine Fire Company, Inc. from the proceeds of certain Host Community Agreement contributions to be made to the Town by Broome County for fire protection at the Broome County Landfill during 2025.

- 3. Each contract, except the contracts with Maine Fire District No. 1, shall continue for a period of one year, from January 1, 2025 until December 31, 2025, and each contract shall be deemed renewed on the same basis each year thereafter for a further term of one calendar year unless one of the contracting parties shall notify the other in writing on or before the twentieth day of August that it elects to terminate the contract on December thirty-first in that year. The term of such contracts, including renewals, shall not exceed five years.
- 4. Each contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.
